RULES OF THE STUDIO

1. ADMISSION TO VISIT CLASSES

No watching of classes by parents and / or family members. Parents will only allow to watch classes by invitation.

2. UNIFORM AND NEATNESS

Prescribed dancewear is compulsory during classes. We expect learners to wear the correct uniform and to have neat hair that will not be a disturbance during lessons. Learners of the ballet classes need to wear their hair in a bun.

2.1 BALLET

PRE-SCHOOL, PRE-PRIMARY – PRIMARY

Lilac leotard with pink ballet shoes. Short or long ballet socks. Pink elastic around the middle. Hair in a ballet bun.

TEST 1 – GRADES

Black leotards with pink ballet shoes. Short or long ballet socks with pink ballet elastic around the middle. Hair in a ballet bun.

2.2 MODERN

JUNIORS

Black leotards, black three-quarter footless tights or ski pants. No shoes.

SENIORS

Leotard, black three-quarter footless tights or ski pants. No shoes or socks. They may wear foot panties.

2.3 HIP-HOP

Any comfortable black ski pants and any black tekkies with black short socks must be worn. WDS branded tops will be available at the studio.

EXAMS

Parents will be informed in due time of any upcoming exams. **No student will be entered for examination with poor attendance record. If exams fall on a weekday or a Saturday, classes will be cancelled and cannot be made-up.**

All extra classes that will be presented to prepare for the exams during holiday or weekends will be FREE.

All private classes @ R 290 / hour.

Registration For 2026

1. **All** dancers, new as well as existing, must please complete a **NEW** enrolment form for 2026.
2. **All new learners must pay a registration fee of R 350. Existing learners will pay a registration fee of R 250.**
3. **IT IS COMPULSORY FOR ALL LEARNERS TO REGISTER WITH WESSELS DANCE STUDIO FOR THE DURATION OF THE YEAR. THIS MEANS THAT PARENTS ARE LIABLE FOR THE FULL FEES FROM REGISTRATION UNTIL THE END OF 2026.**

The only exceptions to this rule are students moving away from this area or those leaving due to serious medical conditions (please supply medical certificate). For these reasons parents must please hand in a written notice letter with 2 months cancelation fee to be paid.

PAYMENTS

1. **Invoices** will be sent out via email prior to the commencement of each month (28th Payments must be made before the 3rd of each month. If a parent falls behind with payments and no communication is made with Tessa or Admin concerning the account, a 10% increase will be added to the fee to cover extra administration charges. This will be applied if payments are not received by the 3rd of the month.
2. **Statements** will be sent out on the 5th of each month.
